VENDING COSTS:

1. 2 day Space - 12 x 12 space *
Craft Vendors \$ 115.00
Food Vendors \$ 200.00
*Discount for 2 or more spaces- contact us for details
2. Non Refundable deposit and signed application will be accepted prior to March 20, 2018.
Craft Vendors Deposit \$ 60.00
Food Vendors Deposit \$ 100.00
3. Full payment must be received by March 20, 2018 *regardless of postmark date!*
4. LATE FEE: A late fee of \$ 75.00 will be applicable if Full payment and or Application are not received by March 20, 2018.
5. SAME –DAY Walk on registration fees are
Craft Vendors \$ 240.00
Food Vendors \$ 325.00
6. Absolutely **NO REFUNDS** will be given after March 20, 2018. Any refund given prior to that date will be less deposit amount regardless of whether a deposit was made prior to payment in full or not.
7. All Vendors are required to donate 1 item to our raffle with a value of \$ 25.00.
8. You will receive a 10% discount for each vendor that you refer that signs up to be a vendor for the 2018 gathering , pays all fees in full and appears on the application were indicated.

CONFIRMATION, ASSIGNMENT, CHECK-IN & SET UP:

1. Vendors will receive an e-mailed confirmation letter once accepted as a vendor. A confirmation letter will only be issued after application and all fees are paid in full.
2. Check-In will begin on Friday, May 4, 2018
3. Vendors unable to check-in and set-up on Friday may check-in and set up Saturday morning, beginning at 8:00am and all vehicles must leave the grounds and be parking in the public lot by 9:00am. Saturday check-in and set-up is by pre-approval only!!!!
4. Vendors will provide their own canopies, tables, chairs, lighting and power.

PARKING:

1. All vehicles must be parked in public lot at all times when not in use for set-up or take down.
2. Overnight camping is based upon prior approval and availability. An additional fee may apply- contact us for details
3. Please pay attention to all posted parking regulations both permanent and temporary.

ELECTRICITY/LIGHTS:

1. Using Camp Pyle electricity and or power supply, unless you are given written permission by an authorized representative of our organization, cancels your vending privileges and your space fee will NOT be refunded.
2. All Generators must be placed on top of plywood. No Exceptions!

SECURITY & OWNED PROPERTY:

1. There is no overnight security designated for vendor space and property. By signing this vendor application you are holding Okla Chahta Clan of California, Inc., its officers and volunteers harmless for any and all damage or theft of goods as well as bodily injuries that may occur to you or your assistants that may occur during our event including set-up and take down of vendor booth.

RESTRICTIONS ON ALLABLE SALE ITEMS:

1. Craft vendors may not sell any type of food or beverage, prepackaged or otherwise.
2. Food vendors may not sell any type of hard goods independent of food and beverage items.
3. Native products and merchandise must be authentic and made by Native American in the United States of America. No foreign imports will be allowed to be sold at our event.
4. Okla Chahta Clan of California, Inc. reserves the right to prohibit vendors for selling or displaying any item which may be disturbing, inappropriate or outside the scope of the description of items to be sold on application.
5. Vendors are not allowed to conduct any type of raffle or drawing at their booth during our event.

RULES AND REGULATIONS:

1. This is a rain or shine event. NO REFUNDS will be given.
2. Driving and parking are allowed only where designated.
3. Vendors will be financially responsible for all damage caused by them to the property of Okla Chahta Clan of California, Inc. and or Pyle's Boys Camp.
4. Vendors must open for business both Saturday and Sunday during the event.
5. By signing the application, you are agreeing to comply with all of the rules and regulations set forth by Okla Chahta Clan of California, Inc. The rules and regulations may change without notice. Furthermore, each individual vendor and or any of their family members/assistance are responsible for being familiar with these regulations for which no exceptions will be made regardless of the person's knowledge of said rule.
